# What should I know or do as a new resident of the City of Ladue?

**We here at City Hall understand that the process of relocating can be a very stressful time in your life and we try to make the process as easy as possible.**

- Residential Occupancy Permits are not required by the City.
- Home inspections are generally not required unless the home has been vacant for more than 6 months or if it is a brand new home.
- We do ask that you stop in City Hall at 9345 Clayton Road to introduce yourself so you can get to know us and we can update our City database with your new information, that way you won't miss out on City notices, meetings, or events.
- Utility information and telephone numbers can be found on the "Helpful Numbers" page.
- If you have or are planning to install a home alarm system, a permit is required. The permit form is available on the City's website or in City Hall.
- The City has a Leaf and Brush Collection Program. More information is available under the "City Services" page. A pick up schedule is available on the City's website.
- The City has licensed several Waste haulers to service Ladue. Residents are responsible for contracting services through one of the licensed haulers. The list is available on the "Helpful Numbers" page.
- Voter Registration is available at the St. Louis County Library at 1640 S. Lindbergh Blvd.
- The U.S. Post Office that services Ladue is located at 331 N New Ballas Rd. Creve Coeur, MO 63141

# Alarm Permitting

New residents must apply for an alarm permit when a new or existing alarm system is installed or activated. The cost for a permit is \$75 per year and billed at the end of October and due December 31<sup>st</sup>. The application is available on the City's website or in City Hall.

# Animal/Vector/Mosquito Control

- Domestic animal control services in the City of Ladue are provided by St. Louis County Animal Control. (314-615-0650 or after hours 314-889-2341)
- Wildlife such as deer and fox are common in Ladue. While this enhances our natural areas, it can become a nuisance in residential neighborhoods. The Bi-State Wildlife Hotline is a free service available to residents to help address wildlife conflict concerns with any species of animals. (636-492-1610) or [www.wildlifeline.com](http://www.wildlifeline.com). If you see an animal in need of assistance please call Wildlife Rescue at 314-394-1880.
- The City of Ladue contracts with St. Louis County for mosquito control.

# Building Permits

The purpose of issuing permits and performing ongoing project inspections is to insure the safety and protect the rights of all Ladue residents. The City of Ladue Building Department is responsible for issuing Building, Plumbing, HVAC, Wrecking, and Tree removal permits within the City. St. Louis County issues all electrical permits. A permit is a license that grants legal permission to start construction of a building project and the enforcement of the building and safety codes which have been adopted as law. Construction projects that require a permit may be performed only after securing a permit. Permits are usually required for most projects beyond cosmetic improvements, such as paint or shingles. This includes all new construction, landscaping, retaining walls, decks, interior and exterior remodels, additions, pools, fences, or tree removal, as well as any plumbing, HVAC, or electrical work. The best way to find out if you need a permit is to visit or call the Ladue Building Department at 314-997-6308.

# Communication

The City of Ladue is committed to open and effective communication. We offer a variety of ways for residents to obtain information about public meetings, upcoming events, City ordinances, City financial information, and more. Please subscribe on our City website for e-mail notifications of important notices and events.

## Brush Collection

A City-wide brush collection will be made March 1<sup>st</sup> – September 30<sup>th</sup> of each year. The City has set specific guidelines concerning what is accepted and how and where brush should be placed for collection. Please refer to the City's website for complete program details.

## Leaf Collection

A City-wide leaf collection will be made October, November, December, and April. Notification cards will be sent out in September with your neighborhood schedule. The City has set specific guidelines concerning what is accepted and how and where leaves should be placed for collection. Please refer to the City's website for complete program details.

**Holiday Tree Collection** - Holiday tree collection is throughout the month of January.

## Garage/Estate Sale Permitting

Sales are permitted in the City of Ladue. If you are hiring someone to manage a sale they are required to obtain an Estate Sale Permit. The cost is \$2 and is good for any sale for 3 years. If you are handling your own garage/yard sale, no permit is required. Please contact the Police Department (314-993-1214) five (5) days prior to your sale so they can place "No Parking" signs on your street the date of the sale. There are some simple conditions for all sales:

- 1 sign on the property is permitted, no directional arrows are allowed
- No display or sale of property in the yard
- Not more than 1 sale per year, lasting more than 2 days in a row

## Solicitors

The City of Ladue has strict regulations regarding door to door solicitation, including the option of being placed on our "[No Solicitation List](#)". This form is available on the City website or at City Hall. While Federal law states we cannot prohibit solicitation, the City of Ladue has instituted a rigorous licensing process that every solicitor must go through, including a Federal and State criminal background check. Licensed solicitors will have a Ladue I.D. available for your inspection upon request. If you are on the "No Solicitation List" and are contacted, or a solicitor will not show you their Ladue I.D., or if you witness someone canvassing in your neighborhood and would simply like Ladue Police to check on them, please immediately call the police, either 911 or the non-emergency line at 314-993-1214.

## Trash and Recycling Programs

The City has licensed several trash haulers to service Ladue. Residents are responsible for contracting services through one of the licensed haulers. Home recycling is available in Ladue through your regular trash collector. Please contact your collector concerning days of service. Blue bags for the storage of recyclables are available at Schnucks or Schnarrs Hardware.

# Police Services

## **Directed Patrol**

When requested, directed patrol will provide increased and specialized patrol of your subdivision to address any special concerns that may require this extra attention. Your district officer will provide personal surveillance to your residence until the matter is resolved. Please notify us if you need this service.

## **Security Survey**

This service is available to both residents and businesses in the City of Ladue. Specially trained Detectives will respond to your business or home to give a thorough security assessment and offer suggestions on how to greatly decrease your chances of being a victim.

## **Subdivision Meetings**

To facilitate the sharing of information between the Police Department and the residents, an Officer, upon invitation, will attend your subdivision meetings to provide a report of criminal activity in your area, educate citizens on crime prevention, and answer any questions on state and local ordinances.

## **Vacation Watch**

If you're going to be away from home for a weekend or an extended period of time PLEASE notify the Police Department and an officer will physically monitor any activity at your home.

# Message from the Fire Chief

The Ladue Fire Department is a full-service, professional department that provides fire suppression, rescue, Advanced Life Support Ambulance service, inspections and public fire prevention education programs for our residents.

We provide service to approximately 8,600 residents in 8.3 square miles. The Fire Department has 32 employees, twenty-nine of which are Paramedics. We have two fire stations, House 1 located at 9213 Clayton Road, houses our Advanced Life Support Ambulance and 1 Heavy Duty Rescue Pumper along with our administrative offices. House 2 located at 9911 Clayton Road houses a Heavy Duty Rescue Pumper. Each fire truck is always staffed with a minimum of three personnel, two of which are always Paramedics. Our Advanced Life Support Vehicle is always staffed with two Paramedic-Firefighters.

We have automatic mutual-aid with every city in the Greater St. Louis Area which provides for seamless response to ever the most challenging emergencies.

The Ladue Fire Department prides itself in being part of the community. We strive to provide a high quality of life for our residents, and take a modern day approach to firefighting and emergency medical services that emphasizes treating our community customers as extended family. We work together with other departments within the City of Ladue to provide excellent service and problem solving for our residents.

The mission of the Ladue Fire Department is to minimize the loss of life and property threatened by the hazards of fire, medical and rescue emergencies, and disaster situations in our community. We accomplish our mission through on-going training and procurement of quality equipment along with a dedicated and professional staff.

# Fire Department Safety Tips

## Fireplace Safety Rules

### Fireplace safety

- Use natural logs. However, if you use the artificial logs, be sure to follow the directions on the package.
- Check your fireplace and chimney often and keep them clean and in good repair.
- Always make sure that a good fire screen is in front of the fireplace.
- Keep the damper open so the draft will remove all smoke and gases when the fireplace is on.
- Keep the area near the fireplace clear of materials like papers, books, toys, etc. Everyone should know about the possibility of flying sparks from the fire and what to do about them.
- Make sure that the fire is completely out before going to bed or if you plan to leave the house.

### Fireplace Dangers

- Do not stack artificial logs in the fireplace as you would real wood.
- Do not use your fireplace if it has loose bricks or needs to be cleaned.
- Do not burn charcoal, coal or plastic materials (wrap, cups, plates, etc.).
- Do not burn garbage in the fireplace.
- Do not ever use gasoline or other such liquid to start or help a fire to start.
- Do not allow small children near the fireplace.
- Do not leave a fire unattended

**Always keep a fire extinguisher close at hand. Make sure that everyone knows how to use it. Keep emergency telephone numbers on or next to the telephone.**

  - Issuance and inspection of Excavation permits for all work within public right-of-way
  - Pavement Maintenance

  - Snow and ice removal

    - Mowing and trimming along City maintained roadways
    - Flail mowing of overhanging vegetation
