Department Reports

Fire Department: The Council reviewed the Fire Department Activity Report for July 2014. The Mayor ordered the report filed.

Chief Bailot reported that the second floor of firehouse #2 has been dry-walled and painting will start next week. The overhead doors will be installed on August 22. Move in is still scheduled for October. Chief Bailot explained change order #12 as a credit of \$7,000.00 for the trade-in of the generator.

Chief Bailot requested approval of a contract amendment with Reinhold Electric to install two video cameras on the emergency traffic signal at Firehouse #2 at a cost of \$5,225.00.

Chief Bailot stated the cameras will provide real time video of Clayton Road and the front of Firehouse #2 when the fire equipment leaves on an emergency call. It will provide a recording of an incident if there is an accident at that location. Chief Bailot advised the cameras will only record when the vehicles leave on an emergency call.

Council Member Howell asked why this system is needed. Chief Bailot explained that the purpose was to protect the City in case of any accident at that location involving City vehicles.

Council Member Hensley inquired if the equipment could be added at a later date. Chief Bailot advised that the cameras could be added later at a cost higher than proposed.

Council Member Fox moved to approve the amended contract with Reinhold Electric at a cost of \$5,225.00 for two video cameras; seconded by Council Member Burroughs, and the vote thereupon was as follows:

Council Member Howell asked about traffic enforcement on S. McKnight Rd. for violators traveling in the wrong lane of traffic during the water main replacement. Chief Wooten stated that directed traffic enforcement could be used in the area.

Public Works: The Mayor and Council reviewed the Public Works report for the period through July 2014. The Mayor ordered the report filed.

Ms. Lamitola requested approval of a contract with North American Salt for a minimum of 480 tons of salt at a cost of \$97.18 per ton, and a commitment to the regional salt cooperative for 500 tons at a cost \$70.73 per ton.
