Moving violations in a School or Construction Zone, violations involving an accident, and any other violation not listed above requires a MANDATORY COURT APPEARANCE.

Anyone under 18 at the time a citation is received must appear in court with a parent or guardian.

All Fines listed above include Court Costs of \$33.50, which is mandated by the State of Missouri.
